SANCTUARY: CONTEMPORARY, POLITICAL

- Bagelman, Jennifer J. Sanctuary City: A Suspended State. London: Palgrave Macmillan, 2016. [PDF]
- Focuses on the sanctuary-city movement in the U.K., specifically Glasgow. Briefly considers the ancient roots of sanctuary, but mostly focuses on sanctuary as a grassroots alternative to asylum. The author has conducted ethnographic research in Glasgow in order to describe the complex of practices that make it a place of sanctuary. She offers a Foucauldian critique of sanctuary as a "noble practice," arguing that sanctuary movements are predicated upon acts of supplication and often lead to oppressive periods of extended waiting, constituting a kind of violence. "Hospitality offered through the sanctuary city challenges yet also extends a hostile state of deferral." The theoretical interventions seem to be pretty ad-hoc, as is the method. Nonetheless, it seems valuable, as she is theorizing "sanctuary" in direct relation to the experience of displaced people involved with grassroots, church-affiliated programs. May provoke conversation.

- Edited volume. Contributions are intended "to show the centrality of religion in the home- and placemaking of vulnerable refugees who have fled humanitarian crises and natural disasters." Thus, "sanctuary" points to religion's role in the social "emplacement" of refugees.

- Per the title, this volume is focused on hospitality more than sanctuary, especially Christian and Islamic traditions of hospitality. This might be a point of overlap worth exploring. Unfortunately, this book is not available online or through our library (it has been ordered) so I have not yet been able to explore the chapters in detail. A few of the chapters look promising. The chapter by Zaman Tahir is especially worth exploring. He has written a recent book on Islamic traditions of refuge (included in this bibliography and in the general bibliography). The chapters are: Pilgrim City or Belonging beyond the State: St. Augustine, Pope Francis and the Refugee Crisis, by Mariano Barbato; The refugee experience as existential exile: Hospitality as a spiritual and political response, by Jean-Marie Carriere; A right to neighbourhood: re-thinking Islamic narratives and practices of hospitality in a sedentarist world, by Tahir Zaman; The limits of hospitality: finding space for faith, by Sadia Kidwai.
